4. FIRST AID MEASURES

6. ACCIDENTAL RELEASE MEASURES

SMALL SPILLS

Dyke or otherwise contain spillage. Particularly prevent ingress of spillage to stormwater drains. Pump spillage into empty drums as much as possible then absorb residues in sand or vermiculite or earth. Transfer to container for disposal. Flush area with water.

LARGE SPILLS

Clear area of all unprotected personnel. Slippery when spilt. Avoid accidents, clean up immediately. Wear protective equipment to prevent skin and eye contamination and the inhalation of vapours. Work up wind or increase ventilation. Contain - prevent run off into drains and waterways. Use absorbent (soil, sand or other inert material).
