## 4. FIRST AID MEASURES

If poisoning occurs, contact a doctor or Poisons Information Centre (Phone Australia 131 126, New Zealand 0800 764 766).

**Inhalation:** If inhaled, remove victim from contaminated area. To protect rescuer, use a Type A (Organic Vapour) respirator or an Airline respirator (in poorly ventilated areas). Apply artificial respiration if not breathing.

**Skin Contact:** If skin contact occurs:- Immediately remove all contaminated clothing, including footwear.- Flush skin and hair with running water and soap (if available).- Seek medical attention in event of irritation.- If fumes or combustion products are inhaled remove from contaminated area.- Lay patient down. Keep warm and rested.- Protheses such as false teeth, which may block airway, should be removed, where possible, prior to initiating first aid procedures.- Apply artificial respiration if not breathing, preferably with a demand valve resuscitator, bag-valve mask device, or pocket mask as trained. Perform CPR if necessary.- Transport to hospital or doctor.

**Eye contact:** If this product comes in contact with the eyes:- Wash out immediately with fresh running water.- Ensure complete irrigation of the eye by keeping eyelids apart and away from eye and moving eyelids by occasionally lifting the upper and lower lids.- Seek medical attention without delay; if pain persists or recurs seek medical attention.- Removal of contact lenses after an eye injury should only be undertaken by skilled personal.

**Ingestion:** If swallowed DO NOT induce vomiting.- If vomiting occurs, lean patient forward or place on left side (head-down position, if possible) to maintain open airway and prevent aspiration.- Observe the patient carefully.- Never give liquid to a person showing signs of being sleepy or with reduced awareness; ie. becoming unconscious.- Give water to rinse out mouth, then provide liquid slowly and as much as casualty can comfortably drink.- Seek medical advice.

## 7. HANDLING AND STORAGE

**Handling:** DO NOT ALLOW CLOTHING WET WITH MATERIAL TO STAY IN CONTACT WITH SKIN. Before use carefully read the product label and data sheet. TWA - The time-weighted average airborne concentration over an eight-hour working day, for a five-day working week over an entire working life.

STEL (Short Term Exposure Limit) - the average airborne concentration over a 15 minute period which should not be exceeded at any time during a normal eight-hour workday.
