4. FIRST AID MEASURES

Product Name: TREMproof 200EC - Part A

If poisoning occurs, contact a doctor or Poisons Information Centre (Phone Australia 131 126, New Zealand 0800 764 766).

Inhalation: Remove victim from exposure - avoid becoming a casualty. Remove contaminated clothing and loosen remaining clothing. Allow patient to assume most comfortable position and keep warm. Keep at rest until fully recovered. Seek medical advice if effects persist.

Skin Contact: Effects may be delayed. If skin or hair contact occurs, immediately remove contaminated clothing



and flush skin and hair with running water. Continue flushing with water until advised to stop by the Poisons Information Centre or a Doctor; or for 15 minutes and transport to Doctor or Hospital.

Eye contact: If in eyes, hold eyelids apart and flush the eyes continuously with running water. Continue flushing until advised to stop by the Poisons Information Centre or a Doctor; or for at least 15 minutes and transport to Doctor or Hospital.

6. ACCIDENTAL RELEASE MEASURES

SMALL SPILLS

11. TOXICOLOGICAL INFORMATION

No adverse health effects expected if the product is handled in accordance with this Safety Data Sheet and the product label. Symptoms or effects that may arise if the product is mishandled and overexposure occurs are:

Acute Effects

Inhalation: Evidence shows, or practical experience predicts, that the material produces irritation of the respiratory system, in a substantial number ofindividuals, following inhalation. In contrast to most organs, the lung is able to respond to a chemical insult by first removing or neutralising theirritant and then repairing the damage. The repair process, which initially evolved to protect mammalian lungs from foreign matter and antigens,may however, produce further lung damage resulting in the impairment of gas exchange, the primary function of the lungs. Respiratory tractirritation often results in an inflammatory response involving the recruitment and activation of many cell types, mainly derived from the vascular system

Skin contact: The material produces moderate skin irritation; evidence exists, or practical experience predicts, that the material eitherproduces moderate inflammation of the skin in a substantial number of individuals following direct contact, and/orproduces significant, but moderate, inflammation when applied to the healthy intact skin of animals (for up to four hours), such inflammationbeing present twenty-four hours or more after the end of the exposure period. Skin irritation may also be present after prolonged or repeated exposure; this may result in a form of contact dermatitis (nonallergic). The dermatitis is often characterised by skin redness (erythema) and swelling (oedema) which may progress to blistering (vesiculation), scaling and thickening of the epidermis. At the microscopic level there may be intercellular oedema of the spongy layer of the skin (spongiosis) and intracellular oedema of the epidermis. Open cuts, abraded or irritated skin should not be exposed to this material Entry into the blood-stream through, for example, cuts, abrasions, puncture wounds or lesions, may produce systemic injury with harmful effects. Examine the skin prior to the use of the material and ensure that any external damage is

suitably protected. A skin sensitiser. Repeated or prolonged skin contact may lead to allergic contact dermatitis.

Ingestion: The material has NOT been classified by EC Directives or other classification systems as "harmful by ingestion". This is because of the lack ofcorroborating animal or human evidence. The material may still be damaging to the health of the individual, following ingestion, especially wherepre-existing organ (e.g liver, kidney) damage is evident. Present definitions of harmful or toxic substances are generally based on dosesproducing mortality rather than those producing morbidity (disease, ill-health). Gastrointestinal tract discomfort may produce nausea andvomiting. In an occupational setting however, ingestion of insignificant quantities is not thought to be cause for concern.

Eye contact: Evidence exists, or practical experience predicts, that the material may cause eye irritation in a substantial number of individuals and/or mayproduce significant ocular lesions which are present twenty-four hours or more after instillation into the eye(s) of experimental animals. Repeated or prolonged eye contact may cause inflammation characterised by temporary redness (similar to windburn) of the conjunctiva(conjunctivitis); temporary impairment of vision and/or other transient eye damage/ulceration may occur.
